

## **Competition Rules**

**Who are we:** Tourism Trio Trivia (referred to in these terms and conditions as the “competition”) is offered to you by Reed Exhibitions (Pty) Ltd (“Reed”) with company registration number 1997/020594/07 and telephone number 011 549 8300. Our principal place of business is 34 Culross Road, Bryanston, Johannesburg, South Africa. Reed Exhibitions (Pty) Ltd is the company that in these Rules is called “we” or “us”. We are the organizer of this competition.

**The law:** This competition shall be conducted in accordance with the provisions of section 36 read with Regulation 11 of the Consumer Protection Act No. 68 of 2008.

**Who can enter:** Entry into the competition is restricted to Reed Exhibition buyers.
